Online Payment facility for Consular Services

The consulate General of India, Frankfurt recently introduced an online payment facility for consular applicants to eliminate various difficulties and risks involved with cash payments. All public in general are once again informed that with effect from 1st April 2022, the Consulate will receive payment for all consular services by way of bank transfer only.

2. We have noticed that in some cases, applicants have deposited the fee in bank account that belong to our outsourced agency, Indo-German Consultancy Services Ltd (IGCS). In one case, applicant has deposited the fee in our Embassy's account in Berlin. Many applicants have transferred the fee to Consulate's account but they have used the IBAN which is not assigned for consular service that they are actually applying for. This is causing delay in accepting the applications.

3. **Applicants are advised to read the information on our website carefully and ensure that they have transferred the correct amount of fee to the correct bank account/IBAN specified for the consular service that they are applying for. The fee should be paid at least two working days prior to the date of appointment. The information regarding the amount of fee and IBANs earmarked to various consular services is available on our website and the same is being furnished hereunder:**

4. The applicants must carry the printout of proof of payment in A-4 size paper and submit it along with the application form at the counter.

5. The Consulate does not accept applications by post. Kindly note that submission of applications by post is possible only through our authorised agency IGCS. It may also be noted that the fee in respect of those applications submitted or sent by post to IGCS should be made directly to IGCS and not to the Consulate.
