- 1. Removal of Carpet in Room No. 1, size 4.20 sqmx 4.20 sqm = 17.70 sqms**
- 2. Removal of Carpet in Room No.2, size 5.10 sqmx 4.00 sqm = 20.50 sqms**
- 3. Removal of Carpet in Room No.3, size 5.10 sqmx3.85 sqm = 20.00 sqms**
- 4. Removal of Carpet in the room between bed room and bath room,
Size 2.65 sqmx4.40 = 11.50 sqms**
- 5. Removal of Carpet in Room No. 4 , size 5.10 sqmx 3.85 sqm = 20.00 sqms**
- 6. Removal of Carpet in Coridoor, size 11.07 sqmx1.50 sqm = 17.00 sqms**
